

## TERMS AND CONDITIONS OF SALE

These terms and conditions ("Agreement") apply to your purchase of products and/or services and support ("Product") sold in the United States by Corevalus Systems, LLC. By accepting delivery of the Product, you accept and are bound to the terms and conditions of this Agreement. If you do not wish to be bound by this Agreement, you must notify Corevalus Systems and return your purchase to Corevalus Systems.

- Other Documents.** This Agreement may NOT be altered, supplemented, or amended by the use of any other document(s) unless otherwise agreed to in a written agreement signed by both you and Corevalus Systems. If you do not receive an invoice or acknowledgement in the mail, via e-mail, or with your Product, information about your purchase may be obtained by contacting your sales representative or visiting [www.samepagemusic.com](http://www.samepagemusic.com).
- Payment Terms; Orders; Quotes; Interest.** Terms of payment are within Corevalus Systems' sole discretion, and unless otherwise agreed to by Corevalus Systems, payment must be received by Corevalus Systems prior to Corevalus Systems' acceptance of an order. Payment for the products will be made by credit card, check, or some other prearranged payment method unless credit terms have been agreed to by Corevalus Systems. Invoices are due and payable within the time period noted on your invoice, measured from the date of the invoice. Corevalus Systems may invoice parts of an order separately. Your order is subject to cancellation by Corevalus Systems, in Corevalus Systems' sole discretion. Unless you and Corevalus Systems have agreed to a different discount, Corevalus Systems' standard pricing policy for Corevalus Systems-branded systems, which include both hardware and services in one discounted price, allocates the discount off list price applicable to the service portion of the system to be equal to the overall calculated percentage discount off list price on the entire system. Corevalus Systems is not responsible for pricing, typographical, or other errors in any offer by Corevalus Systems and reserves the right to cancel any orders resulting from such errors.
- Shipping Charges; Taxes; Title; Risk of Loss.** Corevalus ships via UPS or any other suitable ground shipping freight provider for normal delivery of 150 pounds or less within the continental US. Other shipments are determined on a case-by-case basis. Shipping and handling are additional unless otherwise expressly indicated at the time of sale. Title to products passes from Corevalus Systems to Customer on shipment from Corevalus Systems' facility. Loss or damage that occurs during shipping by a carrier selected by Corevalus Systems is Corevalus Systems' responsibility. Loss or damage that occurs during shipping by a carrier selected by you is your responsibility. Freight damage or shortage claims on common carrier shipments should be immediately registered with the carrier by the recipient in accordance with Federal regulations. Freight claims should be registered directly with the appropriate carrier. Sales Administration at Corevalus should also be informed of any freight issues. You must notify Corevalus Systems within 14 days of the date of your invoice or acknowledgement if you believe any part of your purchase is missing, wrong or damaged. Unless you provide Corevalus Systems with a valid and correct tax exemption certificate applicable to your purchase of Product and the Product ship-to location, you are responsible for sales and other taxes associated with the order. Shipping dates are estimates only.

- Software.** All software is provided subject to a license agreement and you agree that you will be bound by such license agreement in addition to these terms. Title to software remains with the applicable licensor(s).
- Return Policies; Exchanges.** Merchandise may not be returned for credit or exchange without first obtaining a return authorization number from Corevalus. Call Corevalus at (877) 211-0610. A return authorization number is valid for 90 days from the date issued. Authorized returns for credit or exchange must be shipped freight prepaid to Corevalus, 105 Eastside Drive, Suite F, Georgetown, Kentucky, 40324 USA. Returned merchandise must be in new condition - unused and undamaged in any way and returned in its original packaging. Discontinued merchandise cannot be returned. You are responsible for risk of loss, shipping and handling fees for returning or exchanging Product. Additional fees may apply. Opened and resealed cartons are subject to refusal and/or a "used merchandise" adjustment. No merchandise may be returned for credit more than 14 days following date of receipt. Qualified merchandise returned within 14 days following date of receipt may receive full credit. All returns will be charged an additional 15% restocking fee. Non-saleable merchandise will not be accepted and will be returned.
